### Your Role

Safe Work Australia's work contributes to the health and safety of 13 million Australians.

We are seeking candidates with a scientific background, coupled with strong leadership, communication, policy development and stakeholder management skills, to fill several high tempo roles. The work of our team is dynamic and high profile so it is important that candidates can demonstrate the ability to effectively manage competing priorities. Experience in project management is also highly desirable.

The key duties of the Assistant Director roles in the Chemicals Policy and Workplace Exposure Standards Review Section include:

- Leading a small team of APS level staff to deliver on the policy outcomes of the section, including the finalisation of the Workplace Exposure Standards for Airborne Contaminants (WES) review and implementation of the recommendations of the 2018 review of the model Work Health and Safety (WHS) laws regarding Major Hazard Facilities (MHFs).
- Leading the policy development for emerging issues related to hazardous chemicals in the workplace, including but not limited to hydrogen as a fuel source.
- Managing complex policy related work that is guided by relevant legislation, policies, procedures, standards, methodologies and precedents.
- Conducting and/or managing complex research, analysis and policy work and implementing improvement initiatives (including guidance and other communication tools) on chemical policy and related work health and safety matters.
- Leading and coordinating the preparation of high quality web content, including guidance and information sheets, on matters related to hazardous chemicals.
- Participating in the strategic planning, program and policy development and contribute to the success of the section and Agency.

The key duties of the Assistant Director roles in the Occupational Disease and Hygiene Policy Section include:

- Leading a small team of APS level staff to develop and maintain the Agency's guidance on minimising the WHS risks of COVID-19 in Australian workplaces
- Leading development of WHS policy and guidance related to other infectious diseases in the workplace
- Leading development of guidance on managing the risks of asbestos
- Assisting the Agency to deliver the Occupational Lung Diseases work plan, as required.
- Participating in the strategic planning, program and policy development and contribute to the success of the section and Agency.

It is an exciting time to join our teams, with many significant bodies of work being undertaken, including – the finalisation of the WES review, changes to the model WHS laws for respirable crystalline silica, the implementation of the recommendations of the 2018 Review of the model WHS laws related to MHFs and asbestos.
